

## TERMS OF USE

Updated July 10, 2015

**1. CapinCrouse, LLP, herein referred to as CapinCrouse, provides the Church Financial Health Index™ survey, associated reports, and website together referred to as the "Index") as a service for organizations that have registered and participated or paid a fee to CapinCrouse, such organizations are collectively referenced herein as Subscribers. Throughout this agreement "we," "us" or "our" refers to CapinCrouse, and "you," "your," or "Subscriber" refers to any subscriber or authorized user of the Index.**

**2. This Index was created and is administered by CapinCrouse and CapinCrouse grants permission to use the Index to each Subscriber pursuant to the terms herein. CapinCrouse has collaborated with Industry Insights, Inc. for Industry Insights, Inc. to assist CapinCrouse in processing data and preparing reports. All data, content and information provided on or through the Index, including, without limitation, all survey data entered by a user, participant or Subscriber; and any report data (collectively referred to as "Reports"), may be used by you only under the following terms and conditions as set forth in this Terms of Use agreement (the "Agreement"). By becoming a Subscriber, or by accessing or making any use of the Index, you hereby agree to be bound by this Agreement and the terms and conditions set forth herein. The person accepting this Agreement warrants that he or she has the authority to enter into this agreement as themselves or on behalf of the Subscriber.**

**3. Limited Right to Use.** Use of the Index and the Reports is licensed, not sold, to you. As a Subscriber of the Index, you are granted a nonexclusive, nontransferable, revocable, limited license to access and use the Index and the Reports in accordance with this Agreement and the terms of your subscription. CapinCrouse may terminate this Agreement and/or the license granted to Subscriber hereunder upon any failure by Subscriber to timely pay when due any subscription fee or other amount due from Subscriber to CapinCrouse, or any default or breach by Subscriber of any of the terms or conditions of this Agreement or any related subscription order, invoice, or other agreement between Subscriber and CapinCrouse. CapinCrouse authorizes you to view and download materials at this site that is explicitly available for download but you may only use those materials for personal, non-commercial use, and on the condition that you retain all copyright and other proprietary notices contained in the original materials on any copies of the materials. No right, title, or interest in any site content is transferred to you, whether as a result of downloading the content or otherwise. You may not modify the downloadable materials on the Index website in any way or reproduce or publicly display, perform, or distribute or otherwise use them for any public or commercial purpose. Any use of these materials on any other website or networked computer environment for any purpose is prohibited.

**4. Limitations on Use.** The Reports may be used, copied, or stored only by Subscriber and only for the Subscriber's internal business purposes. You agree that you will use this Index and its Reports only as expressly authorized in this Agreement, and that any use not expressly authorized herein is prohibited. You further agree that you will not:

- A. Copy, download, store in any retrieval system, distribute, adapt or transform, publicly display, or publicly present the Index or its Reports, or any portion thereof; except as stated in this Section 4 (Limitations on Use);
- B. Use any network monitoring or discovery software to determine the web site or software architecture, or extract information about usage or about the individual identities of Subscribers or any employee of a Subscriber;
- C. Use any robot, spider, other automatic software or device, or manual process to monitor or copy the Index and/or its Reports;
- D. Use the Index for any illegal purpose or for the submission or transmission of material that is harassing, threatening, libelous, obscene, tortuous or otherwise unlawful or objectionable, or for the distribution of unsolicited mass email messages (spam) or other commercial solicitations; or,
- E. Use the Index or any Reports in a manner which is contrary to any notice, direction or restriction issued in the future by CapinCrouse.

**5. Property Rights of CapinCrouse.** You acknowledge that portions of the Index and its Reports contain and are protected by copyright, trademark, trade secret and/or other intellectual property rights; and that all such intellectual property rights are owned by CapinCrouse. You also agree that, except as expressly provided in this Agreement, nothing in this Agreement or the conduct of the parties shall be construed as conferring on the Subscriber any license or right, by implication, estoppel, or otherwise, under copyright or other intellectual property rights. You also agree to abide by this Agreement regardless of whether any portion of the Index or the Reports is also protected by copyright, trademark, trade secret or any other intellectual property law. All of your obligations and acknowledgements under this Agreement, including without limitation those regarding limitations on use and the intellectual property rights of CapinCrouse, shall expressly survive the termination or expiration of this Agreement.

**6. Subscriber Obligations.** You agree: to provide truthful and accurate registration information as requested by CapinCrouse; to provide accurate and complete survey information; to promptly inform CapinCrouse of any changes to your registration information; to timely pay all subscription fees and other charges as required by CapinCrouse and to abide by all other terms of your subscription agreement with CapinCrouse; to take all reasonable precautions to safeguard access to your password and to prevent unauthorized use of the Index; and to promptly report to CapinCrouse any unauthorized use of your password or the Index of which you become aware.

**7. CapinCrouse Obligations.** Should CapinCrouse terminate the administration of the Index, CapinCrouse shall cease offering subscriptions to potential and current Subscribers and cease collecting data used to compile the survey, but shall continue to fulfill the terms of subscriptions with Subscribers who have already contracted for a subscription until the termination of the then-current annual subscription agreement between CapinCrouse and such Subscriber.

**8. Privacy Policy.** Subject to the use of survey information as permitted in the following Section 9, CapinCrouse agrees to use reasonable efforts to protect the privacy of your information in accordance with the CapinCrouse Privacy Policy as referenced on the Index web site, which Privacy Policy is subject to modification by CapinCrouse from time to time.

**9. Survey Information You Provide.** You hereby grant to CapinCrouse a nonexclusive, perpetual, irrevocable, worldwide, royalty-free license, to reproduce, distribute, modify, sublicense, and to use in any way, all survey responses and other survey-related information which you provide to CapinCrouse during this Agreement, any renewals thereof, and after any termination or expiration thereof. You hereby release CapinCrouse and Industry Insights, Inc., and agree that you shall have no recourse against CapinCrouse or Industry Insights, Inc. for any alleged or actual use, infringement or misappropriation of any proprietary right or information contained or disclosed in your communications to CapinCrouse. This Section 9 shall survive any termination or expiration of this Agreement. Notwithstanding the foregoing, the information that you provide will only be made available to others in aggregate form, such that the information will not be identified as pertaining solely to any one specific Subscriber, or to any one specific individual associated with a Subscriber.

**10. Term.** The initial term of this Agreement shall be for twelve (12) months from the date it is accepted (by clicking on the "I Agree" or similar box), or from such other date as may be specified in any subscription order, invoice or agreement with CapinCrouse (the "Initial Term"). For special promotions, a term may be for other than twelve months as may be specified in any subscription order, invoice or agreement with CapinCrouse. This Agreement and all of your rights therein, including, but not limited to the right to access the Index and your Reports shall automatically terminate at the end of the Initial Term unless you renew this Agreement by paying the appropriate renewal fee. The "Renewal Term" shall be for a period of twelve (12) months from the end of Initial Term or from the end of most previous renewal term. The pricing for the renewal subscription will be at the published pricing as specified on the Index web site at the time of renewal. The term of this Agreement is subject to early termination in the event that Subscriber breaches any term of this Agreement.

- A. THE INDEX AND ALL ITS CONTENT AND REPORTS ARE PROVIDED ON AN AS IS, AS AVAILABLE BASIS. CAPINCROUSE EXPRESSLY DISCLAIMS ALL WARRANTIES, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND NON-INFRINGEMENT.
- B. CapinCrouse and Industry Insights, Inc. make no warranty as to the accuracy, completeness, currency, or reliability of any content available through the index. Use of the Index and the Reports is at subscriber's sole risk. CapinCrouse makes no warranty or representation that the use of the Index or Reports will be uninterrupted, free of errors, defects, viruses or other harmful components, or that the content will always be accessible. CapinCrouse may make improvements or changes to the Index or Report features, functionality, or content at any time.

**12. Limitation of Liability.** CapinCrouse and Industry Insights, Inc. shall not be liable for any loss, injury, claim, liability, or damages of any kind (including without limitation any special, direct, indirect, incidental, or consequential damages or attorneys' fees), whether based in contract, tort, strict liability or otherwise, relating to or arising from: (a) any defects, errors or omissions in this Index or the Reports; (b) the unavailability or inaccessibility of this Index or the Reports, or any portion thereof; (c) your use of this Index or the Reports; or (d) your use of any equipment or software in connection with this Index or the Reports. To the extent the foregoing limitation of liability is limited or prohibited by applicable law, and notwithstanding any other term or provision hereof, the sole aggregate obligation of CapinCrouse to you is limited to providing a refund of the amount of the subscription fees paid by you for the then most recent twelve-month subscription period.

**13. Indemnification.** You hereby indemnify, defend and hold CapinCrouse and Industry Insights, Inc. harmless (as well as their respective officers, directors, shareholders, employees, agents, licensors, suppliers and any third party information providers to the Index or the Reports), from and against all claims, liability, losses, expenses, damages and costs, including reasonable attorneys' fees, resulting from your use of this Index, the Reports (including survey data or other survey-related information), or any breach or failure to comply with any provision of this Agreement by you.

**14. Remedies for Violations.** CapinCrouse reserves the right to seek all remedies available at law and in equity for any breach or failure to comply with any provision of this Agreement by you, including but not limited to the right to block access from a particular internet address to the Index and any other CapinCrouse web site.

**15. Dispute Resolution.** In the event of any dispute, claim, question or disagreement arising from or relating to this Agreement or the breach thereof, the parties hereto shall use their best efforts to settle the dispute, claim, question, or disagreement. To this effect, the parties shall consult and negotiate with each other in good faith and, recognizing their mutual interests, attempt to reach a just and equitable solution satisfactory to both parties. If the parties do not reach such solution within a period of thirty (30) days, then, upon notice by either party to the other, such dispute, claim, question or disagreement shall be resolved by arbitration in Brea, California, in accordance with the Commercial Arbitration Rules of the American Arbitration Association (the "AAA"), subject to the limitations of this Section 15. This agreement to arbitrate will be specifically enforceable under the prevailing law of any court having jurisdiction. Notice of a demand for arbitration shall be filed in writing with the other party hereto and with the AAA. The demand for arbitration shall be made within a reasonable time after the dispute has arisen, and in no event shall any such demand be made after the date when institution of legal or equitable proceedings based on such dispute would be barred by the applicable statute of limitations. The parties agree that one (1) arbitrator shall arbitrate the dispute. The arbitrator shall be selected by the joint agreement of the parties, but if they do not so agree within twenty (20) days after the date of the notice of a demand for arbitration referred to above, the selection shall be made pursuant to the Commercial Arbitration Rules of the AAA from the panels of business arbitrators maintained by the AAA. The decision of the arbitrator shall be made in writing, shall be final, judgment may be entered upon it in any court having jurisdiction thereof, and the decision shall not be subject to vacation, modification or appeal, except to the extent permitted by Sections 10 and 11 of the Federal Arbitration Act, the terms of which Sections the parties agree shall apply. The expenses of arbitration, including reasonable attorneys' fees and the fees and expenses of the arbitrator, shall be shared equally by the parties.

**16. General Contract Provisions.** This Agreement is governed by and construed in accordance with the laws of the State of Indiana. This Agreement incorporates by reference any notices contained on the Index web site and the Privacy Policy. If any provision of this Agreement is deemed unlawful, void or unenforceable, then that provision shall be severed from the remaining provisions and shall not affect their validity and enforceability.

**17. Modifications to Terms of Use.** CapinCrouse reserves the right to change the terms of this Agreement or CapinCrouse Privacy Policy at any time. Updated versions of this Agreement or the Privacy Policy will appear on this Index and are effective immediately. These Terms of Use may be changed without notice from time to time.
