## What should institutions be doing right now for 2024-25 processing?

- Report 2022 calendar-year Federal Work-Study (FWS) earnings to the Common Origination and Disbursement (COD) as soon as possible. (CB-23-13)
- Get your team on the same page for responses to students, families, and institutional constituents. Develop informal scripts to make sure everyone is communicating the same message.

## What should institutions be doing right now for 2024-25 processing? (continued)

- Update current and prospective students on the FAFSA release date. (The statute mandates that the FAFSA is released by the end of 2023 so the date should be accurate.)
- Update your institution's administration, admissions team, business office, and communications department about release dates and any projected awarding timelines you have been able to compile.

## What should institutions be doing right now for 2024-25 processing? (continued)

- Check in with IT staff to see what software updates are expected and the timeline in which you should expect them to be installed to begin the testing of ISIR uploads.
- Reminder: Update policies and procedures as you go. If you make changes or tweak processes, note dates in which you updated the policy or procedure to help auditors and program reviewers follow what occurred.

# What is the unmet need for a student with the following?


