### When should a CFO or finance director at an educational institution consider outsourcing?

- Assistance with Uniform Guidance compliance and reporting – Many higher education institutions receive federal grants and funding. Institutions with federal grant expenditures of \$1 million or more in fiscal years beginning on or after October 1, 2024 (or \$750,000 in fiscal years before that) are required to have a single audit performed and follow Uniform Guidance criteria and reporting requirements, which can be complex. We provide services to advise institutions during this process.
- Nonprofit audit and tax preparation Our team is experienced in helping higher education institutions and K-12 private schools prepare for financial

statement audits or reviews and IRS Forms 990 and 990-T.
